From Senior Caucus Technology Chair

The Statewide Voter Access Network (VAN) is a database available to our DFL Senior Caucus for free to use in our vote-building activities. Technology Chair Bill Middlecamp is available to provide VAN search-output lists on request. There are many search criteria that can be used. The most useful ones are voting districts, Zip codes, age range, sex, probable political affiliation, and voting record. The lists can be printed to PDF files as labels, walking lists, or calling lists, and the lists can be sorted on several attributes, such as precinct, and street address. Before contacting Bill, consider how many names or addresses and the demographic criteria you would like to target. Then, get on Bill's schedule for an interactive session to refine the search

#### **DFL Code of Conduct**

Each time there is an election of leaders in a DFL group, the new and returning leaders are encouraged to sign the DFL Code of Conduct understanding form. Whether or not each leader signs it, they are expected to abide by the DFL Code of Conduct. Senior Caucus board members and Chapter leadership are considered DFL leaders and should abide by the DFL Code of Conduct and sign the form.

In general, the DFL Code of Conduct outlines what behavior will not be tolerated and that the DFL members are expected to act in a respectful manner. This would of course, mean no harassment -- physical, sexual, or otherwise. It also means no bullying, no name calling, and no intimidation. All of those inappropriate types of behaviors provide a "chilling" effect on everyone, not only on the targeted individual but also on any individuals who observe this inappropriate behavior.

It is not enough to say that "I've been here so long everyone knows it's just the way I am" or "I've always 'spoken' my mind." Name calling, bullying, any type of intimidation, are hurtful remarks. These hurtful remarks cannot be tolerated in the DFL party or the Senior Caucus.
